


Figure 1. Distribution of employees by gender in the cross-section of regions

In 2020, the highest share of the population employed in the official sector in the total employment belongs to the regions of Tashkent city (81%), Navoi (67%), Tashkent (47.4%) and Bukhara (46.9%) came The highest rates of employment in the informal sector are in Namangan (68.1%), Surkhandarya (67.8%), Samarkand (66.8%) and Kashkadarya (64.4%) provinces.
