My bridegroom has been so wise since he was little; he sat me down before entering my room on the day of our wedding ceremony and gave me wonderful advice: 'My dear guest! Until you come to our house, you have never stepped foot from our neighborhood, after which you must act sincerely to strengthen these relationships," she said. This student who received good moral education in the family took her husband's advice to heart like a sponge. It has been almost five years since this conversation with the bride took place. Our bride had two children and lived very happily; within five years she did not even once show disrespect by not visiting her home even one more time, I do not know the reason for this, but it may be due to the wisdom of the husband and the fact that the well-bred girl accepted his advice and respected our values.

The great scholar and thinker Abu Rayhan Al-Biruni connects human moral virtues and general ethical concepts with human nature. And human nature is shaped within the family. Therefore, he considered parents' influence on preparing girls for the family as particularly important.

Biruni raises the issue of physical cleanliness and mental purity in families. If there is cleanliness, purity, and orderliness in a family, there will also be spiritual purity there. He does not limit his idea to just keeping oneself clean but calls for taking many actions.

Alisher Navoi also attached great importance to moral and ethical issues in his works; his humanitarian ideals were elevated. The great poet said: "A person with good morals is good for all people and profitable for all people."

The science of pedagogy considers upbringing and education as important factors in preparing girls for family life. According to research results related to pedagogy and psychology, adolescence is the most crucial stage in girls' spiritual formation. At this stage of education aimed at achieving a specific goal affects a person's moral qualities are shaped. A student who has acquired an ethical upbringing from an early age will act based on ethical norms when interacting with others around them and develop morally sound behavior patterns over time. - Good customs, traditions are absent within families leading to negative behaviors being tolerated;
- Various social factors causing isolation within families leading to deviation from social norms.

These reasons actually apply to all boys and girls of any age, including girls who are preparing for a new family life. Therefore, the moral environment, the influence of parents' demands on the family, their authority, influence power, the perspective of family members in their relationships, as well as the importance of their rights and responsibilities are important for every parent. "Every parent must teach their children high moral qualities." However, high moral qualities do not exclude aesthetic culture. The initial stages of aesthetic culture emphasize shaping aesthetic concepts in children's families. In families, national values play a role in shaping moral and aesthetic concepts in children's education. Pedagogue M.Inomova emphasizes that parents should teach children the difference between good and bad behavior in the manners they provide to their children.

The development of aesthetic concepts in girls in the family is part of an overall process - their interest in clothing aesthetics, questions about it, their answers to questions, elements of clothing design in some examples of visual activities indicate that they are moving away from national customs and traditions. Some stages of shaping moral and aesthetic concepts in girls within families pass quietly, and its result is not always visible as a result of purposeful activities. For example, a 4-5 year old girl recites poetry or sings her own song or performs a role from a movie when entering an image. In fact these "skills" were not specifically taught by parents. They are acquired traits from those around them while watching TV shows or observing adults in the family. In some cases acquired traits may not be entirely appropriate for a girl's age. For example, she sings a song with lyrics like "I can't sleep without seeing you" or imitates a part of a movie with war or erotic content. This creates an incorrect aesthetic process for the child. In this regard, parental cultural background plays an important role.

The spiritual world of the family has an indirect impact on social progress and contributes to it even though it is itself part of social progress.

Just as each person has unique secrets, each family has its own secret as well. As we prepare girls for Family Life these things deserve special attention.
